# The existence for the classical solution of the Navier-Stokes equations

#### Abstract

In this paper we will discuss the existence for the classical solution of the NavierStokes equations. First, we transform it into generalized integral equations. Next, we discuss the existence of the classical solution by Leray-Schauder degree and Sobolev space $H^{-m_{1}}\left(\Omega_{1}\right)$. MSC2010. 35AXX.

## 1 Introduction

We consider the dynamical equations for a viscous and incompressible fluid as follows,

where $u=\left(u_{1}, u_{2}, u_{3}\right)^{T}$ is the velocity vector, $\mu$ is the dynamic viscosity coefficient, $\rho$ is the density of the material particle, $p$ is intensity of the pressure, $F=\left(F_{1}, F_{2}, F_{3}\right)^{T}$ is the density of the body force, $u=\left(u_{1}, u_{2}, u_{3}\right)^{T}, p$ and $F$ are all continuous functions with the variables of the time $t$ and position $(x, y, z)^{T}$. These equations are called the Navier-Stokes equations.
We assume $u=\left(u_{1}, u_{2}, u_{3}\right)^{T} \in C^{2}(\bar{\Omega}) \cap C^{1}[0, T], p \in C^{1}(\bar{\Omega}) \cap C[0, T], t \in[0, T],(x, y, z)^{T} \in$ $\bar{\Omega} \subset R^{3}, \bar{\Omega}=\Omega \cup \partial \Omega, \Omega$ is a bounded domain, and $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, moreover, $\bar{\Omega}$ is convex, the initial conditions should be known as

and at least one of three boundary conditions as follows,
(1)Dirichlet problem,

where $n=\left(n_{1}, n_{2}, n_{3}\right)^{T}$ is the exterior normal vector to $\partial \Omega$,
(3)Robin problem,

where $\sigma=\sigma(x, y, z, t)$ is continuous, and $\sigma(x, y, z, t)>0, \forall(x, y, z, t)^{T} \in \partial \Omega \times[0, T]$. Our goal is absolutely the classical solution of $\operatorname{Eqs}(1.1)$ and (1.2).

In Section 2, we will prove that the boundary in $C^{1, \alpha}, 0<\alpha \leq 1$, is not only the Sobolev's imbedding surface, but also the Lyapunov's surface, the Hopf's surface for the strong maximum principle.
In section 3, we will transform $\operatorname{Eqs}(1.1)$ and (1.2) into the equivalent generalized integral equations as follows,

where $Z_{1}=\left(u, p, \partial u \backslash u_{1 x}, \partial^{2} u, \text { gradp }\right)^{T}, \partial u=\left(u_{x}, u_{y}, u_{z}\right)^{T}, \partial u \backslash u_{1 x}=\left(u_{2 x}, u_{3 x}, u_{y}, u_{z}\right)^{T}$, $u_{j x}=\partial u_{j} / \partial x, j=1,2,3, \partial^{2} u=\left(u_{x x}, u_{x y}, u_{x z}, u_{y y}, u_{y z}, u_{z z}\right)^{T}, . *$ means the matrix convolution as follows,

Here generalized comes from $w_{1}$ and $w_{2}$ being related to the Dirac function. The term equivalent is defined in the following.

Definition 1.1 The equations $f_{1}(x)=0$ and $f_{2}(y)=0$ are equivalent, if and only if there exist continuous mappings $T_{1}, T_{2}$, such that $\forall x, y$ are respectively the solutions of $f_{1}(x)=0, f_{2}(y)=0$, we have $f_{1}\left(T_{2}(y)\right)=0, f_{2}\left(T_{1}(x)\right)=0$, and $T_{2}\left(T_{1}(x)\right)=x, T_{1}\left(T_{2}(y)\right)=y$.

Hence, we can get a necessary and sufficient condition for there exist $u \in C^{2}(\bar{\Omega}) \cap C^{1}[0, T], p \in$ $C^{1}(\bar{\Omega}) \cap C[0, T]$ satisfy $\operatorname{Eqs}(1.1)$ and (1.2) is that there exists $Z_{1} \in C(\bar{\Omega} \times[0, T])$ satisfies $Z_{1}=T_{0}\left(Z_{1}\right)$. In Section 4, we will discuss the existence of the classical solution of $Z_{1}=T_{0}\left(Z_{1}\right)$. We will use the theory on $H^{-m_{1}}\left(\Omega_{1}\right)$, where $\Omega_{1}=\Omega \times(0, T)$, which is defined on page 130 in [10], and a primary theory on the Leray-Schauder degree.
At first, we construct a norm $\|\cdot\|_{-m_{1}}$ for $T_{0}\left(Z_{1}\right)=\left(T_{0, i}\left(Z_{1}\right)\right)_{33 \times 1}$ as the following,

Next, we make approximate ordinary integral equations $Z_{1}=T_{0 \epsilon}\left(Z_{1}\right), \forall \epsilon>0$, where

if time $T$ is fixed, then we denote $\tau(M, \epsilon, T)$ into $\tau(M, \epsilon), \Omega_{M}=\left\{Z_{1} \in C\left(\overline{\Omega_{1}}\right):\left\|Z_{1}\right\|_{\infty}<M\right\}$,

We will prove that the strong solution of $Z_{1}=T_{0}\left(Z_{1}\right)$ will exist locally under the condition (1.11) and exist globally under the condition (1.12), where the strong solution $Z_{1}^{*}$ is required that there exist series $\epsilon_{k} \rightarrow 0, k \rightarrow+\infty$, such that

Moreover, the $L^{\infty}$ solution of $Z_{1}=T_{0}\left(Z_{1}\right)$ will exist under the condition (1.13).
If the strong solution is locally integrable, then it is in $L^{\infty}$. If (1.11) or (1.12) or (1.13) does not hold, then the blow-up will happen.
The $L^{\infty}$ solution of $Z_{1}=T_{0}\left(Z_{1}\right)$ will always exist and be unique except the blow-up.
We obtain $u^{*} \in W^{2,+\infty}(\bar{\Omega})$, $p^{*} \in W^{1,+\infty}(\bar{\Omega})$, if $Z_{1}^{*}=T_{0}\left(Z_{1}^{*}\right), Z_{1}^{*} \in L^{\infty}(\bar{\Omega} \times[0, T])$, where $Z_{1}^{*}=\left(u^{*}, p^{*}, \partial u^{*} \backslash u_{1 x}^{*}, \partial^{2} u^{*}, g r a d p^{*}\right)^{T}$. Here $W^{1,+\infty}(\bar{\Omega}), W^{2,+\infty}(\bar{\Omega})$ are Sobolev spaces defined on page 153 in [2]. From the condition that domain $\Omega$ satisfies a uniform exterior and interior cone, if $\Omega$ is bounded, $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, we can get that $u^{*} \in C^{1,1}(\bar{\Omega}), p^{*} \in C^{0,1}(\bar{\Omega})$ by imbedding. By using Morrey's inequality defined on page 163 in [2], we get $u^{*}$ is twice classically differentiable and $p^{*}$ is classically differentiable almost everywhere in $\bar{\Omega}$.
If $F\left(T_{0}\left(Z_{1}^{*}\right)\right)$ is analytical, then $u^{*}$ and $p^{*}$ satisfy $\operatorname{Eqs}(1.1)$ and (1.2) almost everywhere in $\bar{\Omega} \times[0, T]$, where $F\left(T_{0}\left(Z_{1}^{*}\right)\right)$ is the Fourier transform of $T_{0}\left(Z_{1}^{*}\right)$. That is near our goal.
Since we haven't got any similar paper, we have to put some books we have learnt in the reference.

## 2 Boundary in $C^{1, \alpha}$

In this section, we will explain why we chose $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, instead of $\partial \Omega \in C^{2, \alpha}, 0<$ $\alpha \leq 1$, or the Sobolev's imbedding surface, the Lyapunov's surface, the Hopf's surface for the strong maximum principle.
First of all, we know $C^{1, \alpha} \supset C^{2, \alpha}, 0<\alpha \leq 1$. Simplicity and generality are our eternal pursuit. Secondly, $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$ is just the Sobolev's imbedding surface from the following.

Theorem 2.1 If $\Omega$ is bounded, $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, then domain $\Omega$ satisfies a uniform exterior cone condition, that is, there exists a fixed finite right circular cone $K$, such that each $P=(x, y, z)^{T} \in \partial \Omega$ is the vertex of a cone $K(P), \overline{K(P)} \cap \bar{\Omega}=P$, and $K(P)$ is congruent to $K$.

Proof of theorem 2.1. By using the equivalent definition of $C^{1, \alpha}, 0<\alpha \leq 1$, on page 94 in [2], if $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, then each $P_{0}=\left(x_{0}, y_{0}, z_{0}\right)^{T} \in \partial \Omega$, there exists a neighborhood $U\left(P_{0}, \delta_{0}\left(P_{0}\right)\right), \delta_{0}\left(P_{0}\right)>0$, where

U\left(P_{0}, \delta_{0}\left(P_{0}\right)\right)=\left\{P:\left|P-P_{0}\right|<\delta_{0}\left(P_{0}\right)\right\}, \bar{U}\left(P_{0}, \delta_{0}\left(P_{0}\right)\right)=\left\{P:\left|P-P_{0}\right| \leq \delta_{0}\left(P_{0}\right)\right\},
$$

$P=(x, y, z)^{T} \in R^{3},\left|P-P_{0}\right|=\sqrt{\left(x-x_{0}\right)^{2}+\left(y-y_{0}\right)^{2}+\left(z-z_{0}\right)^{2}}$, and $U\left(P_{0}, \delta_{0}\left(P_{0}\right)\right) \cap \partial \Omega$ is a graph of a $C^{1, \alpha}, 0<\alpha \leq 1$, function of two of the coordinates $x, y, z$.
Without loss of the generality, we assume such a function is $f_{0}(x, y) \in C^{1, \alpha}, 0<\alpha \leq 1$, and we have the following, $z-f_{0}(x, y)=0$, if $P=(x, y, z)^{T} \in U\left(P_{0}, \delta_{0}\left(P_{0}\right)\right) \cap \partial \Omega, z-f_{0}(x, y)>0$, if $P=(x, y, z)^{T} \in U\left(P_{0}, \delta_{0}\left(P_{0}\right)\right) \backslash \bar{\Omega}$, and $z-f_{0}(x, y)<0$, if $P=(x, y, z)^{T} \in U\left(P_{0}, \delta_{0}\left(P_{0}\right)\right) \cap \Omega$.

We will get the same results if $U\left(P_{0}, \delta_{0}\left(P_{0}\right)\right) \cap \partial \Omega$ is a graph of other functions.
We introduce the following lemma.
Lemma 2.1 If $\Omega$ is bounded, $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, then for each $P_{0}=\left(x_{0}, y_{0}, z_{0}\right)^{T} \in \partial \Omega$, there exists a $C\left(P_{0}\right)>0$, related to $f_{0}(x, y)$, such that

where $\mathbf{r}_{P_{0} P}=\overrightarrow{P_{0} P}, n_{p_{0}}$ is exterior normal vector to $\partial \Omega$ at point $P_{0}$.
Proof of lemma 2.1. From $n_{p_{0}}=\frac{1}{\sqrt{f_{0 x}^{2}\left(x_{0}, y_{0}\right)+f_{0 y}^{2}\left(x_{0}, y_{0}\right)+1}}\left(-f_{0 x}\left(x_{0}, y_{0}\right),-f_{0 y}\left(x_{0}, y_{0}\right), 1\right)^{T}$, where $f_{0 x}, f_{0 y}$ are partial derivatives of $f_{0}$, we get

From $z-z_{0}=f_{0}(x, y)-f_{0}\left(x_{0}, y_{0}\right)$, and $f_{0}(x, y) \in C^{1, \alpha}$, we have

where $0 \leq t \leq 1$. From $f_{0}(x, y) \in C^{1, \alpha}$, we know there exists $C_{\alpha}\left(P_{0}\right)>0$, related to $f_{0}(x, y)$, such that $\forall P_{1}=\left(x_{1}, y_{1}, z_{1}\right)^{T}, P_{2}=\left(x_{2}, y_{2}, z_{2}\right)^{T} \in \bar{U}\left(P_{0}, \delta_{0}\left(P_{0}\right)\right) \cap \partial \Omega$,

where $\left(P_{1}-P_{2}\right)_{1}=\left(x_{1}-x_{2}, y_{1}-y_{2}, 0\right)^{T}$.
Hence we obtain the following,

where $\left(P-P_{0}\right)_{1}=\left(x-x_{0}, y-y_{0}, 0\right)^{T}$.
From $\sqrt{f_{0 x}^{2}\left(x_{0}, y_{0}\right)+f_{0 y}^{2}\left(x_{0}, y_{0}\right)+1} \geq 1$, we obtain,

where $C\left(P_{0}\right)=2 C_{\alpha}\left(P_{0}\right)$.
Now we can make an exterior finite right circular cone $K\left(P_{0}\right)$ at point $P_{0}$. We choose a $\delta_{1}\left(P_{0}\right)<$ $\delta_{0}\left(P_{0}\right)$ that is small enough such that $C\left(P_{0}\right)\left(2 \delta_{1}\left(P_{0}\right)\right)^{\alpha}<1$. We let $P_{0}$ be the vertex of a cone $K\left(P_{0}\right)$ and $n_{p_{0}}$ be the symmetry axis. The polar angle is $\theta\left(P_{0}\right)=\arccos \left(C\left(P_{0}\right)\left(2 \delta_{1}\left(P_{0}\right)\right)^{\alpha}\right) \in(0, \pi / 2)$, and the length of generatrix is $\delta_{1}\left(P_{0}\right) / 3$.
We will prove that $\overline{K\left(P_{0}\right)} \cap \bar{\Omega}=P_{0}$.
From $\left|P-P_{0}\right| \leq \delta_{1}\left(P_{0}\right) / 3, \forall P \in \overline{K\left(P_{0}\right)}$, we can obtain $\overline{K\left(P_{0}\right)} \subset U\left(P_{0}, \delta_{1}\left(P_{0}\right)\right)$.
And from

\end{equation*}

we can obtain $\overline{K\left(P_{0}\right)} \cap \partial \Omega=P_{0}$.
Finally, if there exists $P \in \overline{K\left(P_{0}\right)} \cap \Omega$, then we can obtain $z<f_{0}(x, y)$, where $P=(x, y, z)^{T}$. From (2.2), we can get $\mathbf{r}_{P_{0} P} \cdot n_{p_{0}}<C\left(P_{0}\right)\left|P-P_{0}\right|^{1+\alpha}$. This contradicts (2.7). Hence $\overline{K\left(P_{0}\right)} \cap \bar{\Omega}=P_{0}$. Then, we can make a uniform exterior finite right circular cone $K$ for each $P \in U\left(P_{0}, \delta_{1}\left(P_{0}\right) / 3\right) \cap \partial \Omega$. $K$ is congruent to $K\left(P_{0}\right)$, if we let $P$ be the vertex of a cone $K(P), n_{p}$ the symmetry axis, a polar angle of $\theta(P)=\theta\left(P_{0}\right)=\arccos \left(C\left(P_{0}\right)\left(2 \delta_{1}\left(P_{0}\right)\right)^{\alpha}\right)$, and the length of generatrix $\delta_{1}\left(P_{0}\right) / 3$. It looks like $C^{1, \alpha}, 0<\alpha \leq 1$, is better than $C^{0,1}$ for the Sobolev's imbedding. However, we do not discuss the weak solution of Eqs(1.1) and (1.2) directly here. We will be discussing the classical solution directly. We want to obtain the equivalent equations that the classical solution should satisfy.
Thirdly, the following two theorems demonstrate that $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, may be taken as the Lyapunov's surface. We will use them in section 3. We require two lemmas as follows.

These last two theorems are the main results in Lyapunov's potential theory on pages 173 to 193 of [6]. We see that $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, can play the role of Lyapunov's surface.
Finally, we see whether $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, is the Hopf's surface for the strong maximum principle. From the example on page 35 of [2], we know it is not the Hopf's surface if domain $\Omega$ only satisfies an interior cone condition. However, we can obtain a stronger condition as follows.

Theorem 2.4 If $\Omega$ is bounded, $\partial \Omega \in C^{1, \alpha}, 0<\alpha \leq 1$, then domain $\Omega$ satisfies a uniform interior oblate spheroid condition, that is, $\exists \delta>0, \forall P_{0} \in \partial \Omega$, there exists a finite right oblate spheroid as follows,

The maximum principle now implies that $u-u\left(P_{0}\right)+\epsilon v_{1} \leq 0$, throughout oblate spheroid $K_{\delta_{1}}\left(P_{0}\right)$. Taking the exterior normal derivative of at $P_{0}$, we obtain, as required,

The reason why we apply the Fourier transform on $\bar{\Omega} \times[0, T]$ instead of $R^{4}$ is that $\operatorname{Eqs}(1.1)$ and (1.2) only holds on $\bar{\Omega} \times[0, T]$. It is possible that they will not stand outside of $\bar{\Omega} \times[0, T]$. We can't apply the Fourier transform on $R^{4}$ to both sides of $\mathrm{Eq}(3.5)$ to (3.15). In order to denote this easily, we define the Fourier transform on $\bar{\Omega} \times[0, T]$ as follows.

Maybe you will point out $\partial h_{2}\left(P_{0}\right) / \partial n_{p_{1}}\left(P_{0}-P_{1}\right)$ is not continuous, if $P_{0}=P_{1}$. Yes, that's true. It's lucky that

is continuous, if $\epsilon_{0} \in(0,0.5]$. Hence $\partial h_{2}\left(P_{0}\right) / \partial n_{p_{1}}\left(P_{0}-P_{1}\right)$ is weak singular kernel. From Fredholm theorem, we know (3.90) still stands.
It looks that the classical solution of $\operatorname{Eqs}(3.22)$ would be locally exist and unique. So were the $\mathrm{Eq}(3.1)$ and $\operatorname{Eqs}(3.2)$. But $F^{-1}\left[f_{1}\right]$ will cause some trouble.
We can work out

We are surprised to see that the inverse Fourier transform of $f_{1}$ on $\partial \Omega_{k}$ is related to $\delta\left[z-f_{k}(x, y)\right]$. This means that $F^{-1}\left[f_{1}\right]$ will be related to $\delta(\partial \Omega)$.
We regret that we lost local existence and uniqueness for the solution of $Z_{1}=T_{0}\left(Z_{1}\right)$. However, it would be too easy if there were no $\delta(\partial \Omega)$. In the next section, we will discuss $Z_{1}=T_{0}\left(Z_{1}\right)$ by Lerry-Schauder degree and the Sobolev space $H^{-m_{1}}\left(\Omega_{1}\right)$, where $\Omega_{1}=\Omega \times(0, T)$.

## 4 Existence

In this section, we will discuss the existence for classical solutions of $Z_{1}=T_{0}\left(Z_{1}\right)$. We include remarks if it is necessary. First of all, we introduce our ideas as follows.
First, we will construct a norm $\|\cdot\|_{-m_{1}}$ for $T_{0}\left(Z_{1}\right)$.
Second, since $Z_{1}=T_{0}\left(Z_{1}\right)$ are generalized integral equations, we make approximate ordinary integral equations $Z_{1}=T_{0 \epsilon}\left(Z_{1}\right), \forall \epsilon>0$, such that $\forall Z_{1} \in C(\bar{\Omega} \times[0, T]),\left\|Z_{1}\right\|_{\infty} \leq M, M$ is given, we have the following,

This will help us to prove $T_{0}\left(Z_{1 k}\right)$ is sequentially compact under norm $\|\cdot\|_{-m_{1}}$, if $\forall Z_{1 k} \in C(\bar{\Omega} \times$ $[0, T]),\left\|Z_{1 k}\right\|_{\infty} \leq M, k \geq 1, M$ is given.
Finally, we use some primary theorems on the Leray-Schauder degree to discuss ordinary integral equations $Z_{1}=T_{0 \epsilon}\left(Z_{1}\right), \forall \epsilon>0$. If $Z_{1 \epsilon}$ satisfies $Z_{1}=T_{0 \epsilon}\left(Z_{1}\right), \forall \epsilon>0$, and bounded uniformly, then there exists a sequence $Z_{1 \epsilon_{k}}, k \geq 1, \epsilon_{k} \rightarrow 0$, if $k \rightarrow+\infty$, such that $Z_{1 \epsilon_{k}}$ is convergent to $Z_{1}^{*}$. We will obtain $Z_{1}^{*}=T_{0}\left(Z_{1}^{*}\right)$, which is what we want.
Can our imagination come true? Let's introduce our answer. The answer is not unique.
Definition 4.1 $\forall Z_{1}=\left(Z_{1, i}\right)_{33 \times 1}, Z_{1, i} \in H^{-m_{1}}\left(\Omega_{1}\right), 1 \leq i \leq 33, \Omega_{1}=\Omega \times(0, T)$, we have

From the Arzela-Ascoli theorem, we know $T_{0 \epsilon}$ is a compact operator on $Z_{1}$. And the Leray-Schauder degree can work now.

If $F\left(T_{0}\left(Z_{1}^{*}\right)\right)$ is analytical, then $u^{*}$ and $p^{*}$ satisfy $\operatorname{Eqs}(1.1)$ and (1.2) almost everywhere in $\bar{\Omega} \times[0, T]$, where $F\left(T_{0}\left(Z_{1}^{*}\right)\right)$ is the Fourier transform of $T_{0}\left(Z_{1}^{*}\right)$. That is near our goal.

## 5 Leray-Schauder degree

In this section, we will discuss the the Leray-Schauder degree of nonlinear integral equation of Hammerstein type as follows,

$$
\begin{equation*}
f(X)=g(X)+T(f(X)), \forall X \in \overline{\Omega_{1}}, \tag{5.1}
\end{equation*}
$$

where

$$
\begin{equation*}
T(f(X))=\int_{\Omega_{1}} k(X, Y) \psi(Y, f(Y)) d Y \tag{5.2}
\end{equation*}
$$

$X=(x, y, z, t)^{T}, Y=\left(x_{1}, y_{1}, z_{1}, t_{1}\right)^{T}, \Omega_{1}=\Omega \times(0, T), f(X)$ is an unknown continuous function on $\overline{\Omega_{1}}, g(X)$ is a known continuous function on $\overline{\Omega_{1}}, k(X, Y)$ is a known continuous function on $\overline{\Omega_{1}} \times \overline{\Omega_{1}}, \psi$ is a known continuous function on $\overline{\Omega_{1}} \times[-M, M]$.
From the definition of the Leray-Schauder degree on page 138 to page 139 in [8], we can work out the Leray-Schauder degree of $\operatorname{Eq}(5.1)$ directly as follows.
By the Weirstrass theorem, we know there exist two polynomials

$$
\begin{equation*}
k_{N}(X, Y)=\sum_{|\alpha|=0}^{N} C_{\alpha}(Y) X^{\alpha}, g_{N}(X)=\sum_{|\alpha|=0}^{N} g_{\alpha} X^{\alpha}, \tag{5.3}
\end{equation*}
$$

where $\alpha=\left(\alpha_{1}, \alpha_{2}, \alpha_{3}, \alpha_{4}\right)^{T},|\alpha|=\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4}, X^{\alpha}=x^{\alpha_{1}} y^{\alpha_{2}} z^{\alpha_{3}} t^{\alpha_{4}}, C_{\alpha}(Y), 0 \leq|\alpha| \leq N$, are all polynomials of $Y$, moreover $\alpha_{1}, \alpha_{2}, \alpha_{3}, \alpha_{4}$ are all nonnegative whole numbers, $g_{\alpha}, 0 \leq|\alpha| \leq N$, are all real numbers, such that $\forall f(X) \in \Omega_{M}=\left\{f(X):\|f(X)\|_{\infty}<M\right\}$, we have

$$
\begin{equation*}
\left\|\int_{\Omega_{1}}\left(k(X, Y)-k_{N}(X, Y)\right) \psi(Y, f(Y)) d Y\right\|_{\infty} \leq \frac{\tau}{3},\left\|g(X)-g_{N}(X)\right\|_{\infty} \leq \frac{\tau}{3}, \tag{5.4}
\end{equation*}
$$

$\tau$ is defined as follows,

$$
\begin{equation*}
\tau=\inf _{\|f(X)\|_{\infty}=M}\|f(X)-T(f(X))-g(X)\|_{\infty}>0 \tag{5.5}
\end{equation*}
$$

From the Combination theory, the number of the solutions of $|\alpha|=\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4}$ is that $C_{3+|\alpha|}^{3}$. The number of all the items $X^{\alpha}, 0 \leq|\alpha| \leq N$, is that $L_{N}=C_{3}^{3}+C_{4}^{3}+\cdots+C_{3+N}^{3}=C_{4+N}^{4}$. By the homotopic, we have the following,

$$
\begin{equation*}
\operatorname{deg}\left(f(X)-T(f(X)), \Omega_{M}, g(X)\right)=\operatorname{deg}\left(f(X)-T(f(X)), \Omega_{M}, g_{N}(X)\right) \tag{5.6}
\end{equation*}
$$

If we assume

$$
\begin{equation*}
T_{N}(f(X))=\int_{\Omega_{1}} k_{N}(X, Y) \psi(Y, f(Y)) d Y \tag{5.7}
\end{equation*}
$$

then from (5.4) we have

$$
\begin{equation*}
\left\|T(f(X))-T_{N}(f(X))\right\|_{\infty} \leq \frac{\tau}{3}, \quad \forall f(X) \in \Omega_{M} \tag{5.8}
\end{equation*}
$$

Moreover,

$$
\begin{equation*}
T_{N}(f(X))=\sum_{|\alpha|=0}^{N}\left(\int_{\Omega_{1}} C_{\alpha}(Y) \psi(Y, f(Y)) d Y\right) X^{\alpha} \in E_{N} \tag{5.9}
\end{equation*}
$$

where $E_{N}$ is the sub-space with finite dimensions generated by $X^{\alpha}, 0 \leq|\alpha| \leq N$. From the definition of the Leray-Schauder degree, we can obtain the following,

$$
\begin{equation*}
\operatorname{deg}\left(f(X)-T(f(X)), \Omega_{M}, g_{N}(X)\right)=\operatorname{deg}\left(f(X)-T_{N}(f(X)), \Omega_{M, 1}, g_{N}(X)\right) \tag{5.10}
\end{equation*}
$$

where $\Omega_{M, 1}=\Omega_{M} \cap E_{N}$.
If we denote

$$
\begin{align*}
f(X) & =\tilde{X}^{T} D_{N}, \tilde{X}=\left(X^{\alpha}, 0 \leq|\alpha| \leq N\right)^{T},  \tag{5.11}\\
D_{N} & =\left(D_{\alpha}, 0 \leq|\alpha| \leq N\right)^{T} \in R^{L_{N}},  \tag{5.12}\\
T_{N}(f(X)) & =\int_{\Omega_{1}} k_{N}(X, Y) \psi(Y, f(Y)) d Y  \tag{5.13}\\
& =\sum_{|\alpha|=0}^{N}\left(\int_{\Omega_{1}} C_{\alpha}(Y) \psi\left(Y, \tilde{Y}^{T} D_{N}\right) d Y\right) X^{\alpha},  \tag{5.14}\\
& =\sum_{|\alpha|=0}^{N} \phi_{\alpha}\left(D_{N}\right) X^{\alpha}=\tilde{X}^{T} \phi\left(D_{N}\right),  \tag{5.15}\\
\phi_{\alpha}\left(D_{N}\right) & =\int_{\Omega_{1}} C_{\alpha}(Y) \psi\left(Y, \tilde{Y}^{T} D_{N}\right) d Y,  \tag{5.16}\\
\phi\left(D_{N}\right) & =\left(\phi_{\alpha}\left(D_{N}\right), 0 \leq|\alpha| \leq N\right)^{T},  \tag{5.17}\\
g_{N} & =\left(g_{\alpha}, 0 \leq|\alpha| \leq N\right)^{T},  \tag{5.18}\\
\Omega_{M, 2} & =\left\{D_{N} \in R^{L_{N}}:\left\|\tilde{X}^{T} D_{N}\right\|_{\infty}<M\right\}, \tag{5.19}
\end{align*}
$$

then we obtain $f(X)=T_{N}(f(X))+g_{N}(X), f(X) \in \Omega_{M, 1}$, is equivalent to

$$
\begin{equation*}
D_{N}=\phi\left(D_{N}\right)+g_{N}, D_{N} \in \Omega_{M, 2} \tag{5.20}
\end{equation*}
$$

Hence, we obtain

$$
\begin{equation*}
\operatorname{deg}\left(f(X)-T(f(X)), \Omega_{M}, g_{N}(X)\right)=\operatorname{deg}\left(D_{N}-\phi\left(D_{N}\right), \Omega_{M, 2}, g_{N}\right) \tag{5.21}
\end{equation*}
$$

From (5.16), we can see that $\phi\left(D_{N}\right)$ is explicit. At this time, we can work out the finite dimensions Brouwer degree $\operatorname{deg}\left(D_{N}-\phi\left(D_{N}\right), \Omega_{M, 2}, g_{N}\right)$ directly. From the definition of the Brouwer degree on page 89 in [8], we only need to calculate the double integral on $\Omega_{M, 2} \times \Omega_{1}$. This is just what we want, the Leray-Schauder degree of $\operatorname{Eq}(5.1)$.
As $\tau$ is fixed, we don't need that $N$ is sufficient big. This is the reason why we haven't discuss the priori estimation yet.
By the same way, we can also work out the Leray-Schauder degree of $\mathrm{Eq}(5.1)$ even if

$$
\begin{equation*}
T(f(X))=\int_{\Omega_{1}} G(X, Y, f(Y)) d Y \tag{5.22}
\end{equation*}
$$

where $G$ is a known continuous function on $\overline{\Omega_{1}} \times \overline{\Omega_{1}} \times[-M, M]$.
We only need to change $k_{N}(X, Y)$ into the following,

$$
\begin{equation*}
k_{N}(X, Y, f(Y))=\sum_{|\alpha|=0}^{N} C_{\alpha, 1}(Y, f(Y)) X^{\alpha}, \tag{5.23}
\end{equation*}
$$

where $C_{\alpha, 1}(Y, f(Y)), 0 \leq|\alpha| \leq N$, are all polynomials of $Y, f(Y)$.
