# FORMAL SELF-ADJOINTNESS OF A FAMILY OF CONFORMALLY INVARIANT BIDIFFERENTIAL OPERATORS 

JEFFREY S. CASE AND ZETIAN YAN


#### Abstract

We prove that the curved Ovsienko-Redou operators and a related family of differential operators are formally self-adjoint. This verifies two conjectures of Case, Lin, and Yuan.


## 1. Introduction

The GJMS operator of order $2 k$, introduced by Graham, Jenne, Mason, and Sparling [7], is a conformally invariant differential operator with leading-order term $\Delta^{k}$ defined on any Riemannian manifold $\left(M^{n}, g\right)$ of dimension $n \geq 2 k$. It can be defined by suitably restricting the power $\widetilde{\Delta}^{k}$ of the Laplacian of the FeffermanGraham ambient space [4]. While $\widetilde{\Delta}^{k}$ is formally self-adjoint in the ambient space, this does not immediately imply that the GJMS operators are formally self-adjoint.

There are now two proofs that the GJMS operators are formally self-adjoint. The first, due to Graham and Zworski 8 (cf. 31), uses a realization of the GJMS operators as poles of the scattering operator of a Poincaré space. The second, due to Juhl [9] (cf. [5), uses a remarkable formula for the GJMS operators in terms of a family of formally self-adjoint second-order differential operators. The first approach relies heavily on the equivalent characterization of the GJMS operators as obstructions to formally extending a function to be harmonic in the ambient space, while the second approach requires a complicated combinatorial argument.

Case, Lin, and Yuan [2] gave two generalizations of the GJMS operators; here we discuss those which are plausibly formally self-adjoint. First is a family of conformally invariant bidifferential operators

of total order $2 k$. They are called the curved Ovsienko-Redou operators bcause they generalize a family of bidifferential operators constructed by Ovsienko and Redou [10] on the sphere. The operators $D_{2 k}$ are determined ambiently by

[^0]on $\widetilde{\mathcal{E}}\left[-\frac{n-2 k}{3}\right] \otimes \widetilde{\mathcal{E}}\left[-\frac{n-2 k}{3}\right]$; in this paper, tensor products are over $\mathbb{R}$. Second is a family of conformally invariant differential operators

D_{2 k, \mathcal{I}}: \mathcal{E}\left[-\frac{n-2 k-2 \ell}{2}\right] \rightarrow \mathcal{E}\left[-\frac{n+2 k+2 \ell}{2}\right]
$$
of order $2 k$ associated to a scalar Weyl invariant $\mathcal{I}$ of weight $-2 \ell$. These are determined ambiently by a scalar Riemannian invariant $\widetilde{I}$ of weight $-2 \ell$ and
\[

on $\widetilde{\mathcal{E}}\left[-\frac{n-2 k-2 \ell}{2}\right]$. See Section 2 for an explanation of our notation and a description of how the ambient formulas determine conformally invariant operators.

The symmetry of the coefficients $a_{r, s, t}$ and $b_{r, s}$ and the observations

\widetilde{\mathcal{E}}\left[-\frac{n-2 k}{3}\right] \ni \widetilde{u}, \widetilde{v}, \widetilde{w} \Longrightarrow \widetilde{u} \widetilde{D}_{2 k}(\widetilde{v} \otimes \widetilde{w}) \in \widetilde{\mathcal{E}}[-n], \\
\widetilde{\mathcal{E}}\left[-\frac{n-2 k-2 \ell}{2}\right] \ni \widetilde{u}, \widetilde{v} \Longrightarrow \widetilde{u} \widetilde{D}_{2 k, \widetilde{I}}(\widetilde{v}) \in \widetilde{\mathcal{E}}[-n],

imply that the induced operators $D_{2 k}$ and $D_{2 k, \mathcal{I}}$ are plausibly formally self-adjoint. Case, Lin, and Yuan [2] conjectured their formally self-adjointness and verified this when $k \leq 3$. The difficulty in this problem is that there is not an equivalent description of these operators as an obstruction to solving some second-order PDE, and hence the Graham-Zworski argument cannot be adapted to $D_{2 k}$ or $D_{2 k, \mathcal{I}}$. Case, Lin, and Yuan instead adapted Juhl's approach, with the constraint $k \leq 3$ due to the difficulty of the combinatorial argument.

In this paper we develop a new, conceptually simple approach to proving formal self-adjointness which verifies the Case-Lin-Yuan conjecture:

Theorem 1.1. Let $\left(M^{n}, g\right)$ be a Riemannian manifold and let $k \in \mathbb{N}$; if $n$ is even, then assume additionally that $k \leq n / 2$. Then $D_{2 k}: \mathcal{E}\left[-\frac{n-2 k}{3}\right]^{\otimes 2} \rightarrow \mathcal{E}\left[-\frac{2 n+2 k}{3}\right]$ is formally self-adjoint.

Theorem 1.2. Let $\left(M^{n}, g\right)$ be a Riemannian manifold, let $k \in \mathbb{N}$, and let $\mathcal{I}$ be a scalar Weyl invariant of weight $-2 \ell$ in the ambient space; if $n$ is even, then assume additionally that $k \leq n / 2$ if $\ell=0$ and $k+\ell \leq n / 2+1$ if $\ell \geq 1$. Then $D_{2 k, \mathcal{I}}: \mathcal{E}\left[-\frac{n-2 k-2 \ell}{2}\right] \rightarrow \mathcal{E}\left[-\frac{n+2 k+2 \ell}{2}\right]$ is formally self-adjoint.

The restrictions on $k$ and $k+\ell$ when $n$ is even ensure that the operators $D_{2 k}$ and $D_{2 k, \mathcal{I}}$, respectively, are independent of the ambiguity of the ambient metric; see Section 2 for details. When $\mathcal{I}=1$, the operator $D_{2 k, \mathcal{I}}$ is a nonzero multiple of the GJMS operator of order $2 k$, and so Theorem 1.2 gives a new proof of its formal self-adjointness.

The main idea in the proofs of Theorems 1.1 and 1.2 is to restrict the ambient operators $\widetilde{D}_{2 k}$ and $\widetilde{D}_{2 k, \widetilde{I}}$ to the Poincaré space $\left(\stackrel{\circ}{X}, g_{+}\right)$equivalent to a given ambient space. Their Dirichlet forms

\left.\int_{r>\varepsilon}\left(\widetilde{u} \widetilde{D}_{2 k}(\widetilde{v} \otimes \widetilde{w})\right)\right|_{\dot{X}} \mathrm{dV}_{g_{+}} \quad \text { and }\left.\quad \int_{r>\varepsilon}\left(\widetilde{u} \widetilde{D}_{2 k, \widetilde{I}}(\widetilde{v})\right)\right|_{\dot{X}} \mathrm{dV}_{g_{+}}
$$

are both in $O(\log \varepsilon)$, and the coefficient of the $\log$ terms are the Dirichlet forms of the respective operators $D_{2 k}$ and $D_{2 k, \mathcal{I}}$ on $M$. The Divergence Theorem implies that there are polydifferential operators $B$ and $B_{\tilde{I}}$ such that

\left.\int_{r>\varepsilon}\left(\widetilde{u} \widetilde{D}_{2 k, \widetilde{I}}(\widetilde{v})-\widetilde{v} \widetilde{D}_{2 k, \widetilde{I}}(\widetilde{u})\right)\right|_{\dot{X}} \mathrm{dV}_{g_{+}} & =\int_{r=\varepsilon} B_{\widetilde{I}}(u \otimes v) \mathrm{dA}_{g_{+}}
\end{aligned}
$$

Moreover, the right-hand sides cannot have a $\log$ term-they are in $O(1)$-and hence $D_{2 k}$ and $D_{2 k, \mathcal{I}}$ are formally self-adjoint; see Section 4 for details.

This paper is organized as follows:
In Section 2 we recall necessary background material on the ambient space and give a unified construction of the operators $D_{2 k}$ and $D_{2 k, \mathcal{I}}$ of Theorem 1.1 and Theorem [1.2, respectively. Our construction differs slightly from that of Case, Lin, and Yuan. We normalize our operators so that $D_{2 k}$ coincides with their construction of the curved Ovsienko-Redou operators. While the operators $D_{2 k, \mathcal{I}}$ do not coincide with the linear operators constructed by Case, Lin, and Yuan [2, Theorem 1.7], the linear spans of our respective operators agree.

In Section 3 we describe the restrictions of $\widetilde{D}_{2 k}$ and $\widetilde{D}_{2 k, \widetilde{I}}$ to $\left(X, g_{+}\right)$and express them in terms of linear combinations of compositions of $\Delta_{g_{+}}+c$ for constants $c \in \mathbb{R}$.

In Section 4 we realize the Dirichlet forms for $D_{2 k}$ and $D_{2 k, \mathcal{I}}$ in terms of the leading-order term of the corresponding Dirichlet forms in $\left(\dot{\circ}, g_{+}\right)$. We then use the simple formulas for the latter operators to deduce Theorems 1.1 and 1.2

## 2. Ambient spaces and the Ovsienko-Redou operators

In this section we recall the construction [2] of the curved Ovsienko-Redou operators and their related linear operators.
2.1. Ambient spaces. We begin by recalling the relevant aspects of the ambient space, following Fefferman and Graham [4].

Let $\left(M^{n}, \mathfrak{c}\right)$ be a conformal manifold of signature $(p, q)$. Denote

\mathcal{G}:=\left\{\left(x, g_{x}\right): x \in M, g \in \mathfrak{c}\right\} \subset S^{2} T^{*} M
$$

and let $\pi: \mathcal{G} \rightarrow M$ be the natural projection. We regard $\mathcal{G}$ as a principal $\mathbb{R}_{+}$-bundle with dilation $\delta_{\lambda}: \mathcal{G} \rightarrow \mathcal{G}, \lambda \in \mathbb{R}_{+}$, given by

\delta_{\lambda}\left(x, g_{x}\right):=\left(x, \lambda^{2} g_{x}\right)
$$

Denote by $T:=\left.\frac{\partial}{\partial \lambda}\right|_{\lambda=1} \delta_{\lambda}$ the infinitesimal generator of $\delta_{\lambda}$. The canonical metric is the degenerate metric $\boldsymbol{g}$ on $\mathcal{G}$ defined by

\boldsymbol{g}(X, Y):=g_{x}\left(\pi_{*} X, \pi_{*} Y\right)
$$

for $X, Y \in T_{\left(x, g_{x}\right)} \mathcal{G}$. Note that $\delta_{\lambda}^{*} \boldsymbol{g}=\lambda^{2} \boldsymbol{g}$.
A choice of representative $g \in \mathfrak{c}$ determines an identification $\mathbb{R}_{+} \times M \cong \mathcal{G}$ via $(t, x) \cong\left(x, t^{2} g_{x}\right)$. In these coordinates, $T_{(t, x)}=t \partial_{t}$ and $\boldsymbol{g}_{(t, x)}=t^{2} \pi^{*} g$.

Extend the projection and dilation to $\mathcal{G} \times \mathbb{R}$ in the natural way:

$$
\begin{aligned}
\pi\left(x, g_{x}, \rho\right) & :=x \\
\delta_{\lambda}\left(x, g_{x}, \rho\right) & :=\left(x, \lambda^{2} g_{x}, \rho\right)
\end{aligned}
$$

where $\rho$ denotes the coordinate on $\mathbb{R}$. We abuse notation and also denote by $T$ the infinitesimal generator of $\delta_{\lambda}: \mathcal{G} \times \mathbb{R} \rightarrow \mathcal{G} \times \mathbb{R}$. Let $\iota: \mathcal{G} \rightarrow \mathcal{G} \times \mathbb{R}$ denote the inclusion $\iota\left(x, g_{x}\right):=\left(x, g_{x}, 0\right)$. A pre-ambient space for $\left(M^{n}, \mathfrak{c}\right)$ is a pair $(\widetilde{\mathcal{G}}, \widetilde{g})$ consisting of a dilation-invariant subspace $\widetilde{\mathcal{G}} \subseteq \mathcal{G} \times \mathbb{R}$ containing $\iota(\mathcal{G})$ and a pseudo-Riemannian metric $\widetilde{g}$ of signature $(p+1, q+1)$ satisfying $\delta_{\lambda}^{*} \widetilde{g}=\lambda^{2} \widetilde{g}$ and $\iota^{*} \widetilde{g}=\boldsymbol{g}$.

An ambient space for $\left(M^{n}, \mathfrak{c}\right)$ is a pre-ambient space $(\widetilde{\mathcal{G}}, \widetilde{g})$ for $\left(M^{n}, \mathfrak{c}\right)$ which is formally Ricci flat; i.e.

- if $n$ is odd, then $\operatorname{Ric}(\widetilde{g}) \in O\left(\rho^{\infty}\right)$;
- if $n$ is even, then $\operatorname{Ric}(\widetilde{g}) \in O^{+}\left(\rho^{n / 2-1}\right)$.

Here $O^{+}\left(\rho^{m}\right)$ is the set of sections $S$ of $S^{2} T^{*} \widetilde{\mathcal{G}}$ such that
(i) $\rho^{-m} S$ extends continuously to $\iota(\mathcal{G})$, and
(ii) for each $z=\left(x, g_{x}\right) \in \mathcal{G}$, there is an $s \in S^{2} T_{x}^{*} M$ such that $\operatorname{tr}_{g_{x}} s=0$ and $\left(\iota^{*}\left(\rho^{-m} S\right)(z)=\left(\pi^{*} s\right)(z)\right.$.
Two ambient spaces $\left(\widetilde{\mathcal{G}}_{j}, \widetilde{g}_{j}\right), j \in\{1,2\}$, for $\left(M^{n}, \mathfrak{c}\right)$ are ambient-equivalent if there are open sets $\mathcal{U}_{j} \subseteq \widetilde{\mathcal{G}}_{j}$ and a diffeomorphism $\Phi: \mathcal{U}_{1} \rightarrow \mathcal{U}_{2}$ such that
(i) $\iota(\mathcal{G}) \subseteq \mathcal{U}_{j}$ for each $j \in\{1,2\}$;
(ii) each $\mathcal{U}_{j}$ is dilation-invariant and $\Phi$ commutes with dilations;
(iii) $\Phi \circ \iota=\iota$;
(iv) if $n$ is odd, then $\Phi^{*} \widetilde{g}_{2}-\widetilde{g}_{1} \in O\left(\rho^{\infty}\right)$;
(v) if $n$ is even, then $\Phi^{*} \widetilde{g}_{2}-\widetilde{g}_{1} \in O^{+}\left(\rho^{n / 2}\right)$.

Fefferman and Graham showed [4, Theorem 2.3] is that if $\left(M^{n}, \mathfrak{c}\right)$ is a conformal manifold, then there is a unique, up to ambient-equivalence, ambient space for $\left(M^{n}, \mathfrak{c}\right)$. In fact, they proved a stronger statement 4, Theorem 2.9(A)]: Let ( $\left.M^{n}, \mathfrak{c}\right)$ be a conformal manifold and pick a representative $g \in \mathfrak{c}$. Then there is an $\varepsilon>0$ and a one-parameter family $g_{\rho}, \rho \in(-\varepsilon, \varepsilon)$, of metrics on $M$ such that $g_{0}=g$ and

$$
\begin{align*}
& \widetilde{\mathcal{G}}:=\mathcal{G} \times(-\varepsilon, \varepsilon), \\
& \widetilde{g}:=2 \rho d t^{2}+2 t d t d \rho+t^{2} g_{\rho} \tag{2.1}
\end{align*}
$$

defines an ambient space $(\widetilde{\mathcal{G}}, \widetilde{g})$ for $\left(M^{n}, \mathfrak{c}\right)$. We say that an ambient metric in the form above is straight and normal.

Let $(\widetilde{\mathcal{G}}, \widetilde{g})$ be the ambient space for $\left(M^{n}, \mathfrak{c}\right)$. Denote by

$$
\widetilde{\mathcal{E}}[w]:=\left\{\widetilde{f} \in C^{\infty}(\widetilde{\mathcal{G}}): \delta_{\lambda}^{*} \widetilde{f}=\lambda^{w} \widetilde{f}\right\}
$$

the space of homogeneous functions on $\widetilde{\mathcal{G}}$ of weight $w \in \mathbb{R}$. Note that $\widetilde{f} \in \widetilde{\mathcal{E}}[w]$ if and only if $T \tilde{f}=w \widetilde{f}$. The space of conformal densities of weight $w$ is

$$
\mathcal{E}[w]:=\left\{\iota^{*} \widetilde{f} \in C^{\infty}(\mathcal{G}): \widetilde{f} \in \widetilde{\mathcal{E}}[w]\right\}
$$

Fix $n \in \mathbb{N}$. An ambient scalar Riemannian invariant $\widetilde{I}$ is an assignment to each ambient space $\left(\widetilde{\mathcal{G}}^{n+2}, \widetilde{g}\right)$ of a linear combination $\widetilde{I}_{\widetilde{g}}$ of complete contractions of

$$
\begin{equation*}
\widetilde{\nabla}^{N_{1}} \widetilde{\mathrm{Rm}} \otimes \cdots \otimes \widetilde{\nabla}^{N_{\ell}} \widetilde{\mathrm{Rm}^{\prime}} \tag{2.2}
\end{equation*}
$$

with $\ell \geq 2$, where $\widetilde{\nabla}$ and $\widetilde{\mathrm{Rm}}$ are the Levi-Civita connection and Riemann curvature tensor, respectively, of $\widetilde{g}$, we regard $\widetilde{\mathrm{Rm}}$ as a section of $\otimes^{4} T^{*} \widetilde{\mathcal{G}}$, and we use $\widetilde{g}^{-1}$ to
take contractions. Any complete contraction of (2.2) is homogeneous of weight

$$
w=-2 \ell-\sum_{i=1}^{\ell} N_{i}
$$

We assume $\ell \geq 2$ because any complete contraction of $\widetilde{\nabla}^{N} \widetilde{\mathrm{Rm}}$ is proportional to $\widetilde{\Delta}^{N / 2} \widetilde{R}$ modulo ambient scalar Riemannian invariants, and $\widetilde{\Delta}^{N / 2} \widetilde{R}=0$ when it is independent of the ambiguity of $\widetilde{g}$. If $\widetilde{I}$ is independent of the ambiguity of $\widetilde{g}$, then $\mathcal{I}:=\iota^{*} \widetilde{I}_{\widetilde{g}} \in \mathcal{E}[w]$ is independent of the choice of ambient space. A scalar Weyl invariant is a scalar invariant $\mathcal{I} \in \mathcal{E}[w]$ constructed in this way. Fefferman and Graham gave a condition on the weight $w$ which implies this independence:
Lemma 2.1 ([4], Proposition 9.1]). Let $\left(\widetilde{\mathcal{G}}^{n+2}, \widetilde{g}\right)$ be a straight and normal ambient space and let $\widetilde{I} \in \widetilde{\mathcal{E}}[w]$ be an ambient scalar Riemannian invariant. If $w \geq-n-2$, then $\iota^{*} \widetilde{I}_{\widetilde{g}}$ is independent of the ambiguity of $\widetilde{g}$.

Bailey, Eastwood, and Graham [1, Theorem A] showed that every conformally invariant scalar of weight $w>-n$ is a Weyl invariant.
2.2. Conformally invariant polydifferential operators. Fix $k, n \in \mathbb{N}$. An ambient polydifferential operator $\widetilde{D}$ of weight $-2 k$ is an assignment to each ambient space $\left(\widetilde{\mathcal{G}}^{n+2}, \widetilde{g}\right)$ of a linear map

$$
\widetilde{D}^{\widetilde{g}}: \widetilde{\mathcal{E}}\left[w_{1}\right] \otimes \cdots \otimes \widetilde{\mathcal{E}}\left[w_{j}\right] \rightarrow \widetilde{\mathcal{E}}\left[w_{1}+\cdots+w_{j}-2 k\right]
$$

such that $\widetilde{D}^{\widetilde{g}}\left(\widetilde{u}_{1} \otimes \cdots \otimes \widetilde{u}_{j}\right)$ is a linear combination of complete contractions of

$$
\begin{equation*}
\widetilde{\nabla}^{N_{1}} \widetilde{u}_{1} \otimes \cdots \otimes \widetilde{\nabla}^{N_{j}} \widetilde{u}_{j} \otimes \widetilde{\nabla}^{N_{j+1}} \widetilde{\operatorname{Rm}} \otimes \cdots \otimes \widetilde{\nabla}^{N_{\ell}} \widetilde{\operatorname{Rm}} \tag{2.3}
\end{equation*}
$$

with $\ell=j$ or $\ell \geq j+2$. Necessarily the powers $N_{1}, \ldots, N_{\ell}$ satisfy

$$
\sum_{i=1}^{\ell} N_{i}+2 \ell-2 j=2 k
$$

The total order of such a contraction is $\sum_{i=1}^{j} N_{i}$. We say that $\widetilde{D}$ is tangential if $\iota^{*}\left(\widetilde{D}^{\widetilde{g}}\left(\widetilde{u}_{1} \otimes \cdots \otimes \widetilde{u}_{j}\right)\right)$ depends only on $\iota^{*} \widetilde{u}_{1}, \ldots, \iota^{*} \widetilde{u}_{j}$ and $\widetilde{g}$ modulo its ambiguity. On each conformal manifold ( $M^{n}, \mathfrak{c}$ ), such an operator determines a conformally invariant polydifferential operator

$$
D: \mathcal{E}\left[w_{1}\right] \otimes \cdots \otimes \mathcal{E}\left[w_{j}\right] \rightarrow \mathcal{E}\left[w_{1}+\cdots+w_{j}-2 k\right] .
$$

We will give a condition on the total order of an ambient polydifferential operator which implies that it is independent of the ambiguity of $\widetilde{g}$. Let $(\widetilde{\mathcal{G}}, \widetilde{g})$ be a straight and normal ambient space for $\left(M^{n}, g\right)$. Following Fefferman and Graham 4, given coordinates $\left\{x^{i}\right\}_{i=1}^{n}$ on $M$ and a multi-index $A=\left(a_{1}, \ldots, a_{r}\right) \in\{0,1, \ldots, n, \infty\}^{r}$, we denote by $\widetilde{T}_{A}=\widetilde{T}_{a_{1} \cdots a_{r}}$ a component of a tensor $\widetilde{T} \in \otimes^{k} T^{*} \widetilde{\mathcal{G}}$, where the index 0 represents $\partial_{t}$, an index $i \in\{1, \ldots, n\}$ represents $\partial_{x^{i}}$, and the index $\infty$ represents $\partial_{\rho}$. The length of $A$ is $|A|:=r$ and the strength of $A$ is

\|A\|:=\left|\left\{j: a_{j} \in\{1, \ldots, n\}\right\}\right|+2\left|\left\{j: a_{j}=\infty\right\}\right|
$$

When $\widetilde{f} \in C^{\infty}(\widetilde{\mathcal{G}})$, we denote $\widetilde{f}_{a_{1} \cdots a_{r}}:=\widetilde{\nabla}_{a_{r}} \ldots \widetilde{\nabla}_{a_{1}} \tilde{f}=:\left(\widetilde{\nabla}^{r} \widetilde{f}\right)_{a_{r} \cdots a_{1}}$.
We first determine the dependence of the covariant derivatives $\widetilde{\nabla}^{r} \widetilde{f}$ of a function $\widetilde{f} \in C^{\infty}(\widetilde{\mathcal{G}})$ on the ambiguity of $\widetilde{g}$ (cf. [4, Proof of Proposition 6.2]).

Lemma 2.2. Let $\left(\widetilde{\mathcal{G}}^{n+2}, \widetilde{g}\right)$ be a straight and normal ambient space and let $\widetilde{f} \in \widetilde{\mathcal{E}}[w]$. Let $A$ be a multi-index of length $r:=|A|$ and strength $s:=\|A\|$. Then $\widetilde{f}_{A} \bmod$ $O\left(\rho^{(n-s) / 2}\right)$ depends only on $\widetilde{g} \bmod O\left(\rho^{n / 2}\right)$.
Proof. The proof is by induction in $r$. Since $\tilde{f} \in \widetilde{\mathcal{E}}[w]$, we see that $\mathcal{L}_{T} \widetilde{\nabla}^{r} \tilde{f}=w \widetilde{\nabla}^{r} \widetilde{f}$. Combining this with the identity $\widetilde{\nabla} T=\widetilde{g}$ yields

$$
\begin{equation*}
\widetilde{\nabla}_{T} \widetilde{\nabla}^{r} \tilde{f}=(w-r) \widetilde{\nabla}^{r} \tilde{f} \tag{2.4}
\end{equation*}
$$

In particular, it suffices to consider the case $(n-s) / 2 \leq n / 2-1$ : If $A$ is a multiindex of strength $s \leq 1$, then Equation (2.4) implies that $\widetilde{f}_{A}$ is proportional to $\widetilde{f}$ (if $s=0$ ) or $\widetilde{f}_{a}$ for some $a \in\{1, \ldots, n\}$ (if $s=1$ ). In either case $\widetilde{f}_{A}$ is independent of $\widetilde{g}$.

We now proceed with the induction. The claim is trivially true when $r=0$. For the inductive step, consider $\widetilde{f}_{A a}$ for $A=\left(a_{1}, \ldots, a_{r}\right)$ a multi-index of length $r$ and $A a:=\left(a_{1}, \ldots, a_{r}, a\right)$ the corresponding multi-index of length $r+1$. Denote $s:=\|A a\|$ and $s^{\prime}:=\|A\|$.

Suppose first that $a \underset{\sim}{=} 0$. Then Equation (2.4) yields $\widetilde{f}_{A a}=(w-r) \tilde{f}_{A}$. The required dependence of $\widetilde{f}_{A a}$ then follows from the inductive hypothesis.

Suppose next that $a \neq 0$. Write

$$
\widetilde{f}_{A a}=\partial_{a} \widetilde{f}_{A}-\widetilde{\Gamma}_{a a_{1}}^{b} \widetilde{f}_{b a_{2} \cdots a_{r}}-\cdots-\widetilde{\Gamma}_{a a_{r}}^{b} \widetilde{f}_{a_{1} \cdots a_{r-1} b}
$$

If $a \neq \infty$, then $s=s^{\prime}+1$ and hence $\partial_{x^{i}} O\left(\rho^{\left(n-s^{\prime}\right) / 2}\right) \subseteq O\left(\rho^{(n-s) / 2}\right)$. If instead $a=\infty$, then $s=s^{\prime}+2$ and hence $\partial_{\rho} O\left(\rho^{\left(n-s^{\prime}\right) / 2}\right)=O\left(\rho^{(n-s) / 2}\right)$. In either case, the inductive hypothesis then gives the required dependence of $\partial_{a} \widetilde{f}_{A}$. We now consider the summand $\widetilde{\Gamma}_{a a_{r}}^{b} \widetilde{f}_{a_{1} \cdots a_{r-1} b}$; the remaining summands are similar. Since $(n-s) / 2 \leq n / 2-1$, the formula [4, Equation (3.16)] for the Christoffel symbols of $\widetilde{g}$ imply that $\widetilde{\Gamma}_{I J}^{K} \bmod O\left(\rho^{(n-s) / 2}\right)$ depends only on $\widetilde{g} \bmod O\left(\rho^{n / 2}\right)$, and so we can ignore the ambiguity caused by the Christoffel symbols. The worst case for the ambiguity caused by the inductive hypothesis is when $b=\infty$ and $a_{r}=0$, so that $\left\|\left(a_{1}, \ldots, a_{r-1}, b\right)\right\|=s^{\prime}+2$. If $a=\infty$, then $s^{\prime}+2=s$, and so the required dependence follows from the inductive hypothesis. If $a \neq \infty$, then the vanishing of the Christoffel symbol $\Gamma_{a 0}^{\infty}$ implies that the worst case does not happen. Thus $\left\|\left(a_{1}, \ldots, a_{r-1}, b\right)\right\| \leq s^{\prime}+1=s$, and so again the required dependence follows from the inductive hypothesis.

We now give a condition on the total order of an ambient polydifferential operator that implies that it is independent of the ambiguity of $\widetilde{g}$ (cf. [4, Proposition 9.1]).
Corollary 2.3. Let $\left(\widetilde{\mathcal{G}}^{n+2}, \widetilde{g}\right)$ be a straight and normal ambient space and let $\widetilde{D}$ be an ambient polydifferential operator of weight $-2 k$. Suppose that
(i) $n$ is odd,
(ii) $k \leq n / 2$, or
(iii) $k \leq n / 2+1$ and $\widetilde{D}$ can be expressed as a linear combination of complete contractions of tensors of the form (2.3) with $\ell \geq j+2$.
Then $\widetilde{D}$ is independent of the ambiguity of $\widetilde{g}$.
Proof. The conclusion is clear when $n$ is odd. Assume that $n$ is even.
Since the component $\widetilde{g}^{a b}$ at $\rho=0$ of the inverse ambient metric is nonzero only if $\|a b\|=2$, we see that a complete contraction of a tensor of the form (2.3) can only
be nonzero on $\mathcal{G}$ if each contracted pair has strength two. Denote by $S_{1}, \ldots, S_{\ell}$ the strengths of the factors in a contributing monomial. Note that the sum of the strengths must equal the total number of indices in a given monomial. Therefore

$$
\begin{equation*}
\sum_{i=1}^{\ell} S_{i}=\sum_{i=1}^{\ell} N_{i}+4(\ell-j)=2(k+\ell-j) \tag{2.5}
\end{equation*}
$$

Clearly $S_{i} \geq 0$ if $i \leq j$. Fefferman and Graham observed [4, Proposition 6.1] that $S_{i} \geq 4$ if $i \geq j+1$.

Suppose first that $k \leq n / 2$. If $i_{0} \in\{1, \ldots, j\}$, then Equation (2.5) yields

$$
S_{i_{0}} \leq \sum_{i=1}^{\ell} S_{i}-4(\ell-j)=2(k-\ell+j) \leq 2 k \leq n
$$

Moreover, equality holds if and only if $k=n / 2$ and $\ell=j$ and $S_{i}=0$ for each $i \neq i_{0}$. If equality holds, then our monomial is proportional to $\left(\prod_{i \neq i_{0}} \widetilde{u}_{i}\right) \widetilde{\Delta}^{n / 2} \widetilde{u}_{i_{0}}$ modulo complete contractions of tensors of the form (2.3) with $\ell \geq j+1$; these will be considered next. Graham et al. observed [7, Section 3] that $\left(\prod_{i \neq i_{0}} \widetilde{u}_{i}\right) \widetilde{\Delta}^{n / 2} \widetilde{u}_{i_{0}}$ is independent of the ambiguity of $\widetilde{g}$. Otherwise Lemma 2.2 implies that the contribution of the factor $\widetilde{\nabla}^{M_{i_{0}}} \widetilde{u}_{i_{0}}$ is independent of the ambiguity of $\widetilde{g}$. If instead $i_{0} \in\{j+1, \ldots, \ell\}$, then $\ell \geq j+1$ and hence Equation (2.5) yields

$$
S_{i_{0}} \leq \sum_{i=1}^{\ell} S_{i}-4(\ell-j-1)=2(k+2-\ell+j) \leq n+2
$$

Moreover, equality holds if and only if $k=n / 2$ and $\ell=j+1$ and $S_{i}=0$ for $i \neq i_{0}$. If equality holds, then our monomial is proportional to $\widetilde{u}_{0} \cdots \widetilde{u}_{j} \widetilde{I}$ for $\widetilde{I}$ a complete contraction of $\widetilde{\nabla}^{n / 2} \widetilde{\mathrm{Rm}}$. Otherwise $S_{i_{0}} \leq n+1$. In either case, Fefferman and Graham showed [4, Propositions 6.2 and 9.1] that the contribution of the factor $\widetilde{\nabla}^{M_{i_{0}}} \widetilde{\mathrm{Rm}}$ is independent of the ambiguity of $\widetilde{g}$. We conclude that our monomial is independent of the ambiguity of $\widetilde{g}$.

Suppose now that $\ell \geq j+2$ and $k \leq n / 2+1$. If $i_{0} \in\{1, \ldots, j\}$, then Equation (2.5) yields

$$
S_{i_{0}} \leq \sum_{i=1}^{\ell} S_{i}-4(\ell-j) \leq 2(k-\ell+j) \leq 2 k-4 \leq n-2
$$

Lemma 2.2 then implies that the contribution of the factor $\widetilde{\nabla}^{M_{i_{0}}} \widetilde{u}_{i_{0}}$ is independent of the ambiguity of $\widetilde{g}$. If instead $i_{0} \in\{j+1, \ldots, \ell\}$, then Equation (2.5) yields

$$
S_{i_{0}} \leq \sum_{i=1}^{\ell} S_{i}-4(\ell-j-1) \leq 2(k+2-\ell+j) \leq 2 k \leq n+2
$$

Moreover, equality holds if and only if $S_{i}=0$ for each $i \leq j$ and $S_{i}=4$ for each $i \in\{j+1, \ldots, \ell\} \backslash\left\{i_{0}\right\}$. Fefferman and Graham showed [4, Propositions 6.2 and 9.1] that the contribution of the factor $\widetilde{\nabla}^{M_{i_{0}}} \widetilde{\mathrm{Rm}}$ is independent of the ambiguity of $\widetilde{g}$. We again conclude that our monomial is independent of the ambiguity of $\widetilde{g}$.

Now let $D: \mathcal{E}\left[-\frac{n-2 k}{j+1}\right]^{\otimes j} \rightarrow \mathcal{E}\left[-\frac{j n+2 k}{j+1}\right]$ be a conformally invariant polydifferential operator. Then for every compact conformal manifold $\left(M^{n}, \mathfrak{c}\right)$, the Dirichlet
form $\mathfrak{D}: \mathcal{E}\left[-\frac{n-2 k}{j+1}\right]^{\otimes(j+1)} \rightarrow \mathbb{R}$ determined by

$$
\mathfrak{D}\left(u_{0} \otimes \cdots \otimes u_{j}\right):=\int_{M} u_{0} D\left(u_{1} \otimes \cdots \otimes u_{j}\right) \mathrm{dV}
$$

is conformally invariant. We say that $D$ is formally self-adjoint if $\mathfrak{D}$ is symmetric. This implies that $D$ is itself symmetric.

We conclude this section by constructing the curved Ovsienko-Redou operators $D_{2 k}$ and their linear analogues $D_{2 k, \mathcal{I}}$. To that end, we identify a tangential linear combination of operators of the form $\widetilde{\Delta}^{k-j} \circ \widetilde{f} \circ \widetilde{\Delta}^{j}$ for some fixed homogeneous function $\widetilde{f} \in \widetilde{\mathcal{E}}\left[w^{\prime}\right]$ (cf. [2, Lemma 6.1]).

Lemma 2.4. Let $(\widetilde{\mathcal{G}}, \widetilde{g})$ be an ambient space for a conformal manifold $\left(M^{n}, \mathfrak{c}\right)$ and let $\widetilde{f} \in \widetilde{\mathcal{E}}\left[w^{\prime}\right]$. Let $k \in \mathbb{N}$ and $w \in \mathbb{R}$. Define $\widetilde{D}_{2 k, w, \widetilde{f}}: \widetilde{\mathcal{E}}[w] \rightarrow \widetilde{\mathcal{E}}\left[w+w^{\prime}-2 k\right]$ by

$$
\begin{aligned}
\widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u}) & :=\sum_{j=0}^{k} a_{j} \widetilde{\Delta}^{k-j}\left(\widetilde{f}^{\Delta^{j}} \widetilde{u}\right), \\
a_{j} & :=\binom{k}{j} \frac{\Gamma\left(j+k-w-w^{\prime}-\frac{n}{2}\right) \Gamma\left(\frac{n}{2}+w-j\right)}{\Gamma\left(k-w-w^{\prime}-\frac{n}{2}\right) \Gamma\left(\frac{n}{2}+w-k\right)} .
\end{aligned}
$$

Then $\iota^{*} \widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u})$ depends only on $\iota^{*} \widetilde{u}, \widetilde{f}$, and $\widetilde{g}$.
Proof. Consider the defining function $Q:=|T|^{2}$ for $\iota(\mathcal{G}) \subseteq \widetilde{\mathcal{G}}$. It suffices to show that the commutator $\left[\widetilde{D}_{2 k, w, \widetilde{f}}, Q\right]=0$ on $\widetilde{\mathcal{E}}[w-2]$, where $Q$ is regarded as a multiplication operator. Graham et al. observed [7] Equation (1.8)] that

$$
\left[\widetilde{\Delta}^{\ell}, Q\right]=2 \ell \widetilde{\Delta}^{\ell-1}(2 T+n+4-2 \ell)
$$

on $C^{\infty}(\widetilde{\mathcal{G}})$ for any $\ell \in \mathbb{N}$. Therefore

$$
\left[\widetilde{D}_{2 k, w, \tilde{f}}, Q\right]=\sum_{j=0}^{k-1} b_{j} \widetilde{\Delta}^{k-j-1} \circ \tilde{f} \circ \widetilde{\Delta}^{j}
$$

on $\widetilde{\mathcal{E}}[w-2]$, where

$$
b_{j}=2(j+1)(n+2 w-2 j-2) a_{j+1}-2(k-j)\left(2 j+2 k-2 w-2 w^{\prime}-n\right) a_{j} .
$$

Our definition of $a_{j}$ yields $b_{j}=0$, and hence $\left[\widetilde{D}_{2 k, w, \widetilde{f}}, Q\right]=0$ on $\widetilde{\mathcal{E}}[w-2]$.
Note that $\widetilde{D}_{k, w, \tilde{f}}$ is not a differential operator in the sense of Subsection 2.1 because we do not require that $\tilde{f}$ is an ambient scalar Riemannian invariant. Applying Lemma 2.4 with a suitably chosen ambient scalar Riemannian invariant does produce a tangential different operator:

Corollary 2.5. Let $\left(M^{n}, \mathfrak{c}\right)$ be a conformal manifold and let $\widetilde{I} \in \widetilde{\mathcal{E}}[-2 \ell]$ be an ambient scalar Riemannian invariant. Let $k \in \mathbb{N}$; if $n$ is even, then assume additionally that
(i) $k \leq n / 2$, if $\ell=0$; and
(ii) $k+\ell \leq n / 2+1$, if $\ell \geq 1$.

Then

$$
\widetilde{D}_{2 k, \widetilde{I}}(\widetilde{u}):=\sum_{r+s=k} \frac{k!}{r!s!} \frac{(\ell+s-1)!(\ell+r-1)!}{(\ell-1)!^{2}} \widetilde{\Delta}^{r}\left(\widetilde{I}^{s} \widetilde{u}\right)
$$

defines a tangential differential operator $\widetilde{D}_{2 k, \widetilde{I}}: \widetilde{\mathcal{E}}\left[-\frac{n-2 k-2 \ell}{2}\right] \rightarrow \widetilde{\mathcal{E}}\left[-\frac{n+2 k+2 \ell}{2}\right]$. In particular, the differential operator

$$
\begin{aligned}
D_{2 k, \mathcal{I}} & : \mathcal{E}\left[-\frac{n-2 k-2 \ell}{2}\right] \rightarrow \mathcal{E}\left[-\frac{n+2 k+2 \ell}{2}\right], \\
D_{2 k, \mathcal{I}}\left(\iota^{*} \widetilde{u}\right) & :=\left(\widetilde{D}_{2 k, \widetilde{I}} \widetilde{u}\right) \circ \iota,
\end{aligned}
$$

is conformally invariant.
Proof. Corollary 2.3 implies that $\widetilde{D}_{2 k, \widetilde{I}}$ is independent of the ambiguity of $\widetilde{g}$. Since $\widetilde{I} \in \widetilde{\mathcal{E}}[-2 \ell]$, applying Lemma 2.4 then implies that

$$
\begin{equation*}
\widetilde{D}_{2 k, \widetilde{I}}=\widetilde{D}_{2 k, w, \widetilde{I}} \tag{2.6}
\end{equation*}
$$

is tangential, where $w:=-\frac{n}{2}+k+\ell$.
The curved Ovsienko-Redou operators arise by looking for tangential linear combinations of the operators $\widetilde{D}_{2 k-2 s, \widetilde{\Delta}^{s} \widetilde{f}}$.
Corollary 2.6. Let $\left(M^{n}, \mathfrak{c}\right)$ be a conformal manifold. Let $k \in \mathbb{N}$; if $n$ is even, then assume additionally that $k \leq n / 2$. Then

$$
\begin{aligned}
\widetilde{D}_{2 k}(\widetilde{u} \otimes \widetilde{v}) & :=\sum_{r+s+t=k} a_{r, s, t} \widetilde{\Delta}^{r}\left(\left(\widetilde{\Delta}^{s} \widetilde{u}\right)\left(\widetilde{\Delta}^{t} \widetilde{v}\right)\right) \\
a_{r, s, t} & :=\frac{k!}{r!s!t!} \frac{\Gamma\left(\frac{n+4 k}{6}-r\right) \Gamma\left(\frac{n+4 k}{6}-s\right) \Gamma\left(\frac{n+4 k}{6}-t\right)}{\Gamma\left(\frac{n-2 k}{6}\right) \Gamma\left(\frac{n+4 k}{6}\right)^{2}}
\end{aligned}
$$

defines a tangential bidifferential operator $\widetilde{D}_{2 k}: \widetilde{\mathcal{E}}\left[-\frac{n-2 k}{3}\right]^{\otimes 2} \rightarrow \widetilde{\mathcal{E}}\left[-\frac{2 n+2 k}{3}\right]$. In particular, the bidifferential operator

$$
\begin{aligned}
D_{2 k} & : \mathcal{E}\left[-\frac{n-2 k}{3}\right]^{\otimes 2} \rightarrow \mathcal{E}\left[-\frac{2 n+2 k}{3}\right], \\
D_{2 k}\left(\iota^{*} \widetilde{u} \otimes \iota^{*} \widetilde{v}\right) & :=\widetilde{D}_{2 k}(\widetilde{u} \otimes \widetilde{v}) \circ \iota
\end{aligned}
$$

is conformally invariant.
Proof. Corollary 2.3 implies that $\widetilde{D}_{2 k}$ is independent of the ambiguity of $\widetilde{g}$. Since $\widetilde{D}_{2 k}(\widetilde{u} \otimes \widetilde{v})=\widetilde{D}_{2 k}(\widetilde{v} \otimes \widetilde{u})$, it thus suffices to show that $\widetilde{D}_{2 k}(\widetilde{u} \otimes \widetilde{v}) \circ \iota$ depends only on $\iota^{*} \widetilde{v}, \widetilde{u}$, and $\widetilde{g}$ in order to conclude that $\widetilde{D}_{2 k}$ is tangential. Observe that

$$
\begin{equation*}
\widetilde{D}_{2 k}(\widetilde{u} \otimes \widetilde{v})=\sum_{s=0}^{k}\binom{k}{s} \frac{\Gamma\left(\frac{n+4 k}{6}-s\right) \Gamma\left(\frac{n-2 k}{6}+s\right)^{2}}{\Gamma\left(\frac{n-2 k}{6}\right) \Gamma\left(\frac{n+4 k}{6}\right)^{2}} \widetilde{D}_{2 k-2 s,-\frac{n-2 k}{3}, \widetilde{\Delta} s \widetilde{u}}(\widetilde{v}) \tag{2.7}
\end{equation*}
$$

Applying Lemma 2.4 to each $\widetilde{D}_{2 k-2 s,-\frac{n-2 k}{3}, \widetilde{\Delta}^{s} \widetilde{u}}$ implies that $\widetilde{D}_{2 k}(\widetilde{u} \otimes \widetilde{v}) \circ \iota$ depends only on $\iota^{*} \widetilde{v}, \widetilde{u}$, and $\widetilde{g}$.

## 3. Poincaré spaces

In this section we give an equivalent description of the operators $\widetilde{D}_{2 k, w, \widetilde{f}}$ from Lemma 2.4 in terms of the Poincaré space determined by a straight and normal ambient metric. We restrict our attention to the case $w=-\frac{n+w^{\prime}-2 k}{2}$, where $w^{\prime}$ is the weight of $\tilde{f}$, as it is only in this case that the operator on $\left(M^{n}, g\right)$ induced by $\widetilde{D}_{2 k, w, \tilde{f}}$ can be formally self-adjoint.

Let $(\widetilde{\mathcal{G}}, \widetilde{g})$ be the straight and normal ambient space (2.1) for a representative $\underset{\sim}{g} \in \mathfrak{c}$ of a conformal manifold $\left(M^{n}, \mathfrak{c}\right)$. Set $r:=\sqrt{-2 \rho}$ and $s:=r t$ in the domain $\widetilde{\mathcal{G}}_{+}:=\{\rho<0, t>0\} \subseteq \widetilde{\mathcal{G}}$. In these coordinates,

$$
\begin{align*}
\widetilde{g} & =-d s^{2}+s^{2} g_{+} \\
g_{+} & =r^{-2}\left(d r^{2}+g_{-r^{2} / 2}\right) \tag{3.1}
\end{align*}
$$

The equation $\widetilde{g}(T, T)=-1$ defines a hypersurface $X \subseteq \widetilde{\mathcal{G}}$. Since $T=t \partial_{t}$, we see that $\stackrel{\circ}{X}=\{s=1\}$. Using Equation (3.1) to compute the Laplacian $\widetilde{\Delta}$ of $\widetilde{g}$ in terms of the Laplacian of $g_{+}$yields

$$
\begin{equation*}
\widetilde{\Delta}=s^{-2}\left(\Delta_{g_{+}}-\left(s \partial_{s}\right)^{2}-n s \partial_{s}\right) \tag{3.2}
\end{equation*}
$$

Suppose that $\widetilde{u} \in \widetilde{\mathcal{E}}[w]$. Thus there is a one-parameter family of functions $u_{\rho} \in C^{\infty}(M)$ such that $\widetilde{u}(t, x, \rho)=t^{w} u_{\rho}(x)$. Equivalently, $\widetilde{u}(r, x, s)=s^{w} \widehat{u}(r, x)$, where $\widehat{u} \in C^{\infty}(X)$ is the function $\widehat{u}(r, x)=r^{-w} u_{-r^{2} / 2}(x)$. In particular, $\widetilde{u}$ is determined by its restriction $\widehat{u}=\left.\widetilde{u}\right|_{X}$. Moreover, Equation (3.2) implies that

$$
\begin{equation*}
\widetilde{\Delta} \widetilde{u}=s^{w-2}\left(\Delta_{g_{+}}-w(n+w)\right) \widehat{u} . \tag{3.3}
\end{equation*}
$$

This leads to a formula relating the operators $\widetilde{D}_{2 k, w, \widetilde{f}}$ and

$$
P_{2 j, w}:=\prod_{i=0}^{j-1}\left(\Delta_{g_{+}}-(w-2 i)(n+w-2 i)\right)
$$

on $\left(\stackrel{\circ}{X}, g_{+}\right)$:
Lemma 3.1. Let $(\widetilde{\mathcal{G}}, \widetilde{g})$ be the straight and normal ambient space for a representative $g \in \mathfrak{c}$ of a conformal manifold $\left(M^{n}, \mathfrak{c}\right)$. Let $\left(\dot{X}, g_{+}\right)$be the Poincaré manifold determined by the variables $r, s$ as in Equation (3.1). Let $\widetilde{f} \in \widetilde{\mathcal{E}}\left[w^{\prime}\right]$ and let $k \in \mathbb{N}$. Set $w:=-\frac{n+w^{\prime}-2 k}{2}$. If $\widetilde{u} \in \widetilde{\mathcal{E}}[w]$, then

$$
\begin{aligned}
\left.\widetilde{D}_{2 k, w, \tilde{f}}(\widetilde{u})\right|_{\hat{X}} & =\sum_{i=0}^{k} \sum_{j=0}^{k-i} c_{i, j}\left(P_{2 i, w} \circ \widehat{f} \circ P_{2 j, w}\right)(\widehat{u}), \\
c_{i, j} & :=4^{k-i-j} \frac{k!}{i!j!} \frac{\Gamma\left(\frac{n}{2}+w-i\right) \Gamma\left(\frac{n}{2}+w-j\right)}{\Gamma\left(\frac{n}{2}+w-k\right)^{2}},
\end{aligned}
$$

where $\widehat{u}:=\left.\widetilde{u}\right|_{X}$ and $\widehat{f}:=\left.\widetilde{f}\right|_{X}$.

Proof. Note that $w+w^{\prime}-k=k-n-w$. Lemma 2.4 and Equation (3.3) yield

$$
\begin{align*}
&\left.\widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u})\right|_{X}=\sum_{j=0}^{k}\binom{k}{j} \frac{\Gamma\left(\frac{n}{2}+w-k+j\right) \Gamma\left(\frac{n}{2}+w-j\right)}{\Gamma\left(\frac{n}{2}+w-k\right)^{2}}  \tag{3.4}\\
& \times\left(P_{2 k-2 j, 2 k-2 j-n-w} \circ \widehat{f} \circ P_{2 j, w}\right)(\widehat{u})
\end{align*}
$$

On the one hand, a simple reindexing in the definition of $P_{2 j, w}$ yields

$$
\begin{equation*}
P_{2 k-2 j, 2 k-2 j-n-w}=P_{2 k-2 j, w-2} . \tag{3.5}
\end{equation*}
$$

On the other hand, direct computation yields

$$
\Delta_{g_{+}}-(w-2 j)(n+w-2 j)=\Delta_{g_{+}}-w(n+w)+2 j(n+2 w-2 j)
$$

It follows that

$$
P_{2 j, w-2}=P_{2 j, w}+4 j\left(\frac{n}{2}+w-j\right) P_{2 j-2, w-2}
$$

A simple induction argument yields

$$
\begin{equation*}
P_{2 j, w-2}=\sum_{i=0}^{j} 4^{i} \frac{j!}{(j-i)!} \frac{\Gamma\left(\frac{n}{2}+w-j+i\right)}{\Gamma\left(\frac{n}{2}+w-j\right)} P_{2 j-2 i, w} . \tag{3.6}
\end{equation*}
$$

Combining Equations (3.4), (3.5), and (3.6) yields

$$
\begin{array}{r}
\left.\widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u})\right|_{\dot{X}}=\sum_{j=0}^{k} \sum_{i=0}^{k-j} 4^{i} \frac{k!}{j!(k-i-j)!} \frac{\Gamma\left(\frac{n}{2}+w-k+i+j\right) \Gamma\left(\frac{n}{2}+w-j\right)}{\Gamma\left(\frac{n}{2}+w-k\right)^{2}} \\
\times\left(P_{2 k-2 i-2 j, w} \circ \widehat{f} \circ P_{2 j, w}\right)(\widehat{u}) .
\end{array}
$$

Reindexing the sum yields the final result.

## 4. Formal self-adjointness

We are now ready to prove the formal self-adjointness of the curved OvsienkoRedou operators $D_{2 k}$ and the conformally invariant operators $D_{2 k, \mathcal{I}}$. To that end, we identify their associated Dirichlet forms as the logarithmic term in the expansion of the corresponding Dirichlet form in a Poincaré space. More generally:
Lemma 4.1. Let $(\widetilde{\mathcal{G}}, \widetilde{g})$ be the straight and normal ambient space for a representative $g \in \mathfrak{c}$ of a conformal manifold $\left(M^{n}, \mathfrak{c}\right)$. Denote by $\left(\dot{X}, g_{+}\right)$the Poincaré space determined by the variables $r, s$ as in Equation (3.1). Let $\widetilde{f} \in \widetilde{\mathcal{E}}\left[w^{\prime}\right]$ and let $k \in \mathbb{N}$. Set $w:=-\frac{n+w^{\prime}-2 k}{2}$. Define $D_{2 k, w, \tilde{f}}: C^{\infty}(M) \rightarrow C^{\infty}(M)$ by

$$
D_{2 k, w, \tilde{f}}(u):=\left.\widetilde{D}_{2 k, w, \widetilde{f}}\left(t^{w} \pi^{*} u\right)\right|_{t=1, \rho=0}
$$

If $\widetilde{u}, \widetilde{v} \in \widetilde{\mathcal{E}}[w]$, then

$$
\left.\int_{r>\varepsilon}\left(\widetilde{v} \widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u})\right)\right|_{\dot{X}} \mathrm{dV}_{g_{+}}=-\left(\int_{M} v D_{2 k, w, \widetilde{f}}(u) \mathrm{d} \mathrm{~V}_{g}\right) \log \varepsilon+O(1)
$$

as $\varepsilon \rightarrow 0$, where $u:=\left.\widetilde{u}\right|_{t=1, \rho=0}$ and $v:=\left.\widetilde{v}\right|_{t=1, \rho=0}$.

Proof. Note that $2 w+w^{\prime}-2 k=-n$. Thus $\widetilde{v} \widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u}) \in \widetilde{\mathcal{E}}[-n]$. Therefore

$$
\left.\left(\widetilde{v} \widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u})\right)\right|_{\dot{X}}=v D_{2 k, w, \widetilde{f}}(u) r^{n}+O\left(r^{n+2}\right)
$$

as $r \rightarrow 0$. Graham observed [6, Equations (3.1) and (3.2)] that

$$
\mathrm{dV}_{g_{+}}=r^{-n-1}\left(1+O\left(r^{2}\right)\right) \mathrm{dV}_{g} d r
$$

as $r \rightarrow 0$. Direct calculation yields the final result.
Combining Lemmas 3.1 and 4.1 implies that $D_{2 k, w, \tilde{f}}$ is formally self-adjoint.
Proposition 4.2. Let $(\widetilde{\mathcal{G}}, \widetilde{g})$ be the straight and normal ambient space for a representative $g \in \mathfrak{c}$ of a conformal manifold $\left(M^{n}, \mathfrak{c}\right)$. Denote by $\left(\dot{X}, g_{+}\right)$the Poincaré space as in Equation (3.1). Let $\widetilde{f} \in \widetilde{\mathcal{E}}\left[w^{\prime}\right]$ and let $k \in \mathbb{N}$. Set $w:=-\frac{n+w^{\prime}-2 k}{2}$. Define $D_{2 k, w, \tilde{f}}: C^{\infty}(M) \rightarrow C^{\infty}(M)$ as in Lemma 4.1. Then

$$
\int_{M} v D_{2 k, w, \widetilde{f}} u \mathrm{dV}_{g}=\int_{M} u D_{2 k, w, \widetilde{f}}(v) \mathrm{d} V_{g}
$$

for every compactly supported $u, v \in C^{\infty}(M)$.
Proof. Let $u, v \in C^{\infty}(M)$ be compactly supported. Set $\widetilde{u}:=t^{w} \pi^{*} u$ and $\widetilde{v}:=t^{w} \pi^{*} v$. Given a function $\phi=\phi(\varepsilon)$ such that $\phi \in O(\log \varepsilon)$ as $\varepsilon \rightarrow 0$, denote

$$
\operatorname{lp} \phi:=\lim _{\varepsilon \rightarrow 0} \frac{\phi(\varepsilon)}{\log (1 / \varepsilon)}
$$

First, Lemma 4.1 yields

$$
\begin{align*}
& \int_{M}\left(v D_{2 k, w, \tilde{f}}(u)-u D_{2 k, w, \widetilde{f}}(v)\right) \mathrm{d} V_{g}  \tag{4.1}\\
&=\left.\operatorname{lp} \int_{r>\varepsilon}\left(\widetilde{v} \widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{u})-\widetilde{u} \widetilde{D}_{2 k, w, \widetilde{f}}(\widetilde{v})\right)\right|_{\dot{X}} \mathrm{dV}_{g_{+}}
\end{align*}
$$

Second, Lemma 3.1 and the symmetry $c_{i, j}=c_{j, i}$ yield

$$
\begin{align*}
& \left.\int_{r>\varepsilon}\left(\widetilde{v} \widetilde{D}_{2 k, w, \tilde{f}}(\widetilde{u})-\widetilde{u} \widetilde{D}_{2 k, w, \tilde{f}}(\widetilde{v})\right)\right|_{\dot{X}} \mathrm{dV}_{g_{+}}  \tag{4.2}\\
& =\sum_{i+j=0}^{k} c_{i, j} \int_{r>\varepsilon}\left(\widehat{v}\left(P_{2 i, w} \circ \widehat{f} \circ P_{2 j, w}\right)(\widehat{u})-\widehat{u}\left(P_{2 j, w} \circ \widehat{f} \circ P_{2 i, w}\right)(\widehat{v})\right) \mathrm{d} \mathrm{~V}_{g_{+}},
\end{align*}
$$

where $\widehat{u}:=\left.\widetilde{u}\right|_{\dot{X}}$ and $\widehat{v}:=\left.\widetilde{v}\right|_{\dot{X}}$. Third, observe that if $0 \leq j \leq i$, then

$$
P_{2 i, w}=P_{2 i-2 j, w-2 j} \circ P_{2 j, w}
$$

Let $\widehat{\varphi}, \widehat{\psi} \in C^{\infty}(\stackrel{\circ}{X})$. Write

$$
\begin{aligned}
& \int_{r>\varepsilon}\left(\widehat{\varphi} P_{2 i, w} \widehat{\psi}-\widehat{\psi} P_{2 i, w} \widehat{\varphi}\right) \mathrm{dV} g_{g_{+}} \\
& \quad= \sum_{\ell=1}^{i} \int_{r>\varepsilon}\left(\left(P_{2 i-2 \ell, w-2 \ell \widehat{\varphi})} P_{2 \ell, w} \widehat{\psi}-\left(P_{2 i-2 \ell+2, w-2 \ell+2} \widehat{\varphi}\right) P_{2 \ell-2, w} \widehat{\psi}\right) \mathrm{dV} g_{g_{+}}\right. \\
&= \sum_{\ell=1}^{i} \int_{r>\varepsilon}\left(\left(P_{2 i-2 \ell, w-2 \ell \widehat{\varphi}) \Delta_{g_{+}} P_{2 \ell-2, w} \widehat{\psi}-\left(\Delta_{g_{+}} P_{2 i-2 \ell, w-2 \ell \widehat{\varphi})} P_{2 \ell-2, w} \widehat{\psi}\right) \mathrm{dV}_{g_{+}}}\right.\right.
\end{aligned}
$$

The Divergence Theorem yields

$$
\begin{aligned}
& \int_{r>\varepsilon}\left(\widehat{\varphi} P_{2 i, w} \widehat{\psi}-\widehat{\psi} P_{2 i, w} \widehat{\varphi}\right) \mathrm{d} V_{g_{+}} \\
& \quad=\sum_{\ell=1}^{i} \int_{r=\varepsilon}\left(\left(P_{2 i-2 \ell, w-2 \ell \widehat{\varphi})} \nabla_{\mathrm{n}} P_{2 \ell-2, w} \widehat{\psi}-\left(\nabla_{\mathrm{n}} P_{2 i-2 \ell, w-2 \ell} \widehat{\varphi}\right) P_{2 \ell-2, w} \widehat{\psi}\right) \mathrm{dA}_{g_{+}},\right.
\end{aligned}
$$

where n and $\mathrm{dA}_{g_{+}}$are the outward-pointing unit normal and the area element, respectively, of $\{r=\varepsilon\}$ with respect to $g_{+}$. In particular,

$$
\operatorname{lp} \int_{r>\varepsilon}\left(\widehat{\varphi} P_{2 i, w} \widehat{\psi}-\widehat{\psi} P_{2 i, w} \widehat{\varphi}\right) \mathrm{dV}_{g_{+}}=0
$$

Combining this with Equation (4.1) and (4.2) yields the final result.
Our main results follow from Proposition 4.2 and tangentiality.
Proof of Theorem 1.1. By Corollary [2.6, it suffices to compute in the straight and normal ambient space associated to a representative $g \in \mathfrak{c}$. Equation (2.7) and Proposition 4.2 express $D_{2 k}$ as a linear combination of formally self-adjoint operators. Therefore $D_{2 k}$ is formally self-adjoint.

Proof of Theorem 1.2. By Corollary 2.5, it suffices to compute in the straight and normal ambient space associated to a representative $g \in \mathfrak{c}$. Combining Equation (2.6) with Proposition 4.2 realizes $D_{2 k, \mathcal{I}}$ as a formally self-adjoint operator.
